A Message from Fr. Kubista:

Our rights come from God and cannot be changed by man. That is good because if man is allowed to change them, he could change them to fit his desires, which at times can be evil, go against God. Governments (like our State) have been given authority, ultimately by God, and are to enact laws which align with the rights given to us by God.

A person has an obligation before God to accept the gender that they were created with at the moment of their conception. The English word gender ultimately comes from the Latin word genus which means "kind", "type", or "sort". When God created Adam and Eve, He made them male and female, which means there are only two genders ("kinds") of human persons, male and female. Therefore, at the moment of conception, a person is a specific gender which is marked in the DNA of every cell, which cannot be changed, and determines their growth and "potential".

Our State Government is undermining our God given rights in part by defining perceived "acceptable" terms in laws they create. In 2023, they entirely changed the definition of sexual orientation and added the definition for gender identity in the Minnesota Human Rights Act (MHRA) (363A.03 - Definitions). "Sexual orientation" means to whom someone is, or is perceived of as being, emotionally, physically, or sexually attracted to based on sex or gender identity. A person may be attracted to men, women, both, neither, or to people who are genderqueer, androgynous, or have other gender identities. "Gender identity" means a person's inherent sense of being a man, woman, both, or neither. A person's gender identity may or may not correspond to their assigned sex at birth or to their primary or secondary sex characteristics. A person's gender identity is not necessarily visible to others." These definitions are broad, undermine God's order (His plan), and imply that those who have disordered movements within are not disordered (their behavior is acceptable).

The MN Legislature added the gender identity class to the MHRA in 2023 and is changing it again this year. MHRA (363A.02 - Public Policy) says that persons are free from discrimination in employment, housing and real property, public accommodations, and education in one or more of (proposed in 2024) the following classes: race, color, creed, religion, national origin, sex, gender identity (added in 2023), marital status, disability, status with regard to public assistance, sexual orientation, familial status, and age. The Legislature changed the MHRA in 2023 (363A.08 - Unfair Discriminatory Practices Relating to Employment or Unfair Employment Practice) to include gender identity. Labor Organizations, an Employer, and an Employment Agency cannot accept/hire, expel/discharge, or discriminate in various ways against persons because of race, color, creed, religion, national origin, sex, gender identity, marital status, status with regard to public assistance, familial status, disability, sexual orientation, or age nor ask them if they fall into any of these classes.

What MN Legislature did not change in 2023 was MHRA (363A.20 - Exemption Based on Employment) and MHRA (363A.26 - Exemption Based on Religious Association) to include gender identity. When an amendment (SF 3848) was brought up in Committee on 3/22/2024 to add the exemption for gender identity to respect the beliefs of Religious Organizations, it was voted down which means that the exemption for gender identity was purposely not amended in 2023 and thus is an attack on religious liberty. The MN Legislature is trying to enshrine violations to the dignity of the human person by having citizens vote to have the *Equal Rights Amendment* added to the State Constitution. Minnesota HF 173 says that if passed, the following will be added to article 1, section 18:"*Equality under the law shall not be abridged or denied by this state or any of its cities, counties, or other political subdivisions on account of race, color, creed, sex, sexual orientation, gender identity or expression, age, disability, ancestry, or national origin."*

We can pray for our State, contact our State Officials on these matters, and elect God centric Legislators. We love a person by affirming the gender God created them with at conception (male or female) and helping them to live that out in their lives. God bless you.
